Applications for CIPET Distinguished Alumni Award 2024

Maintaining good relationships with alumni over time is crucial to the success of an educational institution. Alumni serve many valuable roles, such as helping to build and grow an institution's brand through word-of-mouth marketing. The alumni of an Institution can provide mentoring, internships, and career opportunities to students. Thus helping the students of the Institute to secure a better future. Further, alumni bring in much-needed resource through gurudakshina, helping the institution for outreach program, etc., which prove helpful to the Institution on the global front. These are just a few of the reasons why alumni are important to the success of Institutions.

It is proposed to start the “**CIPET DISTINGUISHED ALUMNUS AWARDS (CIPET DAA)**” with a view to strengthening the bond between the alumni and the Institute by recognizing their achievements.

The Distinguished Alumnus Award (DAA) is given to a person who has been awarded a Post Graduate or Under Graduate Degree/Diploma/ Post Diploma/Post Graduate Diploma certificate pertaining to training from CIPET to recognize his/her outstanding contributions in one of the categories of the award listed below

1. Excellence in Engineering or Technology Innovation/ Entrepreneurship
2. Excellence in Leadership in the Government/Public Sector/ Private Sector
3. Excellence in Service to the Society
4. Academic Excellence
5. Research Excellence
6. Women Empowerment (only for female candidates)

Further, awards under a special category “**Young CIPET DAA**” is also proposed.

The awards shall comprise a memento and a certificate. The award felicitation shall be carried out during the annual function of CIPET. Even a special program can also be organized for this.

Criteria

Nominations for DAA are invited from all over the world and anybody can nominate the deserving alumni of CIPET. An alumnus, to be nominated for the Award, should have

made a significant professional contribution in any of the above-mentioned categories, which is recognized widely. The following shall also be considered while assessing the nominations:

1. Positions held
2. Contributions to his/her profession in the relevant category
3. Awards and Honors Received
4. Other contributions

Eligibility

Any student who has received academic cum training credentials from the CIPET is eligible to be considered for CIPET DAA.

The Distinguished Young Alumnus Awards (DYAA) would be conferred on CIPET alumni below 35 years, as on 1st January of the year in question, for outstanding contributions in their chosen field of work.

The following aspects will be considered for DYAA, among possible others, for assessing the contributions of the nominees.

- Accomplishments and recognitions that exhibit pursuit of excellence or path-breaking work or innovation or creativity in the chosen field of work.
- Track record of leadership roles and responsibilities which demonstrate potential for continued success.

Dead Line: Applications are accepted from 25th December, 2024 to 25th January 2025.

Screening Committee:

The screening committee will be constituted by Director General to review the application Centrewise as well as Central level. The number of screening committee to be constituted will be finalized based on the number of application received in each category.

The screening committee will review the submitted application for Eligibility and submit their recommendations to Standing committee for finalization of awardees in different category.

The screening committee will comprise of following members.

1. Director/Principal Director - Chairperson
2. Expert from Industry/industrial association (1 No.) – Member
3. Expert from Society / Institute (1 No.) – Member
4. Head office representative - Member

Standing Committee:

The applications submitted by screening committee will be scrutinized by standing committee and the awardees in each category will be finalized by the committee.

The standing committee consist of following members.:

1. Director General, CIPET – Chairperson
2. Nominated GC member (1 No) - Member
3. Expert from Industry/industrial association (1 No.) – Member
4. Expert from Society / Institute (1 No.) – Member

In addition to that each committee will have a women representative to scrutinize the applications received under women empowerment category.
